

Cross entity authorisation nomination form

Online services for business and Standard Business Reporting

Complete this form if you are the authorising individual for one or more entities, and would like to authorise a representative entity to access the nominating entities' protected information and to act on their behalf in relation to their tax affairs, including changes and updates to tax information. This authorisation is restricted to Online services for business and Standard Business Reporting and therefore only relates to users authorised by the representative entity in Relationship Authorisation Manager (RAM).

Authorising individual

This form is to be completed by an individual who is authorised for tax law purposes to act on behalf of the entities listed in Section B. The authorising individual for all entities making the nomination will generally be a:

- public officer (for tax law purposes)
- director of a company
- partner of a partnership
- individual trustee of a trust or director of a Corporate Trustee, or
- for other organisations either the:
 - president or chair
 - vice-president or vice-chair
 - treasurer
 - secretary
 - equivalent positions with responsibility for the overall management of the organisation.

The authorising individual is required to make the Declaration at question 3 in Section B of this form.

Conditions for Online services for business and Standard Business Reporting arrangements

The Online services for business and Standard Business Reporting services may be withdrawn if:

- the Commissioner decides to withdraw the service
- the nominated entity has breached the terms under which the authorisation was given
- a user is found to have breached the myGovID terms of use or ATO online terms and conditions, including using another individual's myGovID login
- the nominated representative entity no longer represents an entity named on this form. The nominating entity will need to call us to cancel this nomination when they no longer want the representative entity to act on their behalf.

- Place X in the applicable boxes
- Sign and date the declaration at the end of the form
 Ensure all mondatory fields marked with an asterial.
- Ensure all mandatory fields marked with an asterisk (*) are completed
- The ATO may request supporting documents to process your application.
