WHEN TO USE THIS FORM

Use this form if you want us to retain your refund for verification purposes under paragraph 8AAZLGA(1)(b) of the *Taxation Administration Act 1953* (TAA 1953) and you are either:

- lodging your activity statement
- a full self-assessment taxpayer for income tax purposes (for example, a company or super fund) lodging your tax return.

You do not have to use this form; however, we encourage you to use it as it will give us the information we need to process your request.

If you make your request after you have lodged your return, we may have already processed your return and issued your refund by the time we get your request. To make sure we can action your request quickly, we encourage you to phone us on 13 28 66 and we will help you complete the form.
