

Notification of conversion of a multiple entry consolidated (MEC) group to a consolidated group

A conversion event occurs when an existing multiple entry consolidated (MEC) group becomes a consolidated group. This happens when the provisional head company is the sole eligible tier-1 company in the group and it no longer fulfils the eligibility requirements to be a provisional head company of a MEC group but is eligible to be the head company of a consolidated group.

Who should complete this form

This form should be completed by the public officer, agent, trustee or registered tax agent of the head company.

How to complete this form

This form can be completed on screen. When complete, print, sign and date the declaration at the end of the form.

If completing by hand:

- print clearly in BLOCK LETTERS using a black or dark blue pen
- place **X** in **all** applicable boxes.
