

Notification of continuation of a multiple entry consolidated (MEC) group with a new provisional head company

A MEC group is a group of Australian entities that is wholly foreign-owned and does not have a common Australian resident head company.

This form is not sufficient to satisfy the requirement to make a 'choice in writing' to appoint a new provisional head company.

WHO SHOULD COMPLETE THIS FORM

This form should be completed by the public officer, agent, trustee or registered tax agent of the new provisional head company.

HOW TO COMPLETE THIS FORM

This form can be completed on screen. When complete, print, sign and date the declaration at the end of the form.
