

## SMSF regulatory contravention disclosure

#### When to use this form

Use this form to make a voluntary disclosure of an unrectified contravention of the *Superannuation Industry (Supervision) Act 1993* by a self-managed superannuation fund (SMSF).

The voluntary disclosure can only be accepted if sufficient details have been provided. This includes how it is proposed to rectify the contravention or a proposed enforceable undertaking.

If you make a voluntary disclosure about contraventions that occurred in previous years, you must lodge any outstanding SMSF annual returns.

Some contraventions attract administrative penalties. We will consider your voluntary disclosure when determining any remission of penalties.

It is still a requirement for an SMSF auditor to report regulatory contraventions via an Auditor/actuary contravention report (ACR). However, the ATO will not commence an audit based on an

ACR if the issue has been or is being resolved via a voluntary disclosure unless additional information that warrants further investigation becomes available.

### Whistleblower requirements

Don't use this form if you are reporting a contravention that involved another trustee in the fund and you want your identity kept confidential.

Instead make a tip off to the Tax Integrity Centre by going to ato.gov.au/tipoff.

### Completing this request

Complete the required fields electronically, print the document which must be signed by one or more SMSF trustees or directors of the corporate trustee and lodge the form using the instructions provided at the end of this document.
